T2 is growing within the canopy of T1 and has bad form, will be left exposed when T1 is removed. T3 has had a large stem removed and now has decay present at the base of the tree along with a potentially weak basal union. Dieback present within crown of tree, limited life expectancy. 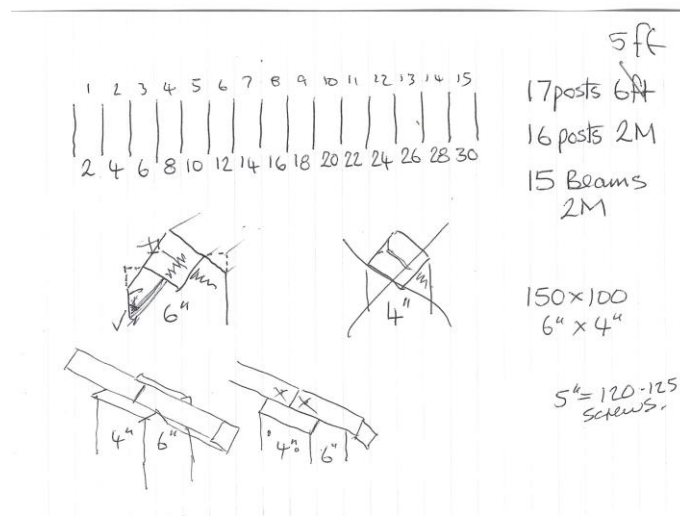
